Applicants must provide proof of income qualification by providing documentation of income for each member of the household. The total household income cannot exceed the levels shown in the chart above. Acceptable proof may include the following:

- W2, most recent
- · Recent pay stubs
- · Social Security awards letter

Applicants must include proof of homeownership inside the city limits of Anniston. This proof may include:

- · Copy of deed
- Tax record, most recent

Applicants must authorize the use of volunteer labor for housing repairs.

The Housing Division of the Department of Community Development will be responsible for certification of program eligibility.

Type of Projects

Projects eligible for consideration will be limited to repair or replacement of decks, handicap ramps, and exterior painting or vinyl siding, or other minor exterior work. Applicants should check each type of work they need on the application form. However, they must understand that World Changers may choose to select only one of these projects.

Selection Criteria

- Final selection of houses will be at the sole discretion of World Changers.
- Since most of the volunteers are teenagers and young adults, safety of the crews is of utmost importance.
 Houses must be single level, must not be of excessive height. If scaffolding is required these groups will not attempt the project.
- All applications must be received by March 7, 2025. Applications received after the deadline will not be reviewed—no exceptions.
- Proof of income and homeownership inside the city limits of Anniston. Each of these requirements is clearly stated on the application form.
- Applications without proper documentation are considered ineligible.
