



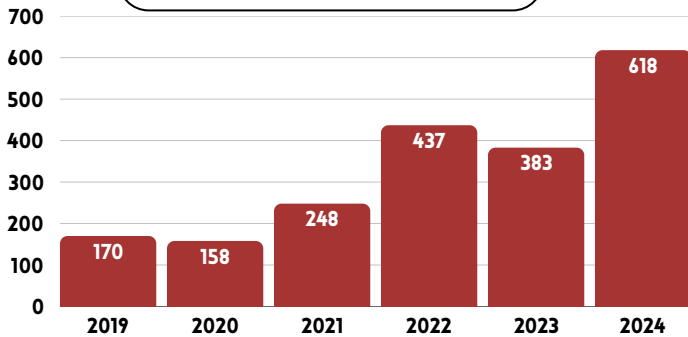

# FISCAL YEAR 2024: BY THE NUMBERS

- Since 2020, business licenses have more than tripled: **291.14%**.
- Construction Investment Nearly Quadrupled Since 2020: From \$14.49M in 2020 to \$57.24M in 2024 - a **295%** increase.
- General Fund revenues have grown over **32%** since FY15.
- Sales tax revenues have increased over **38%** since FY15.

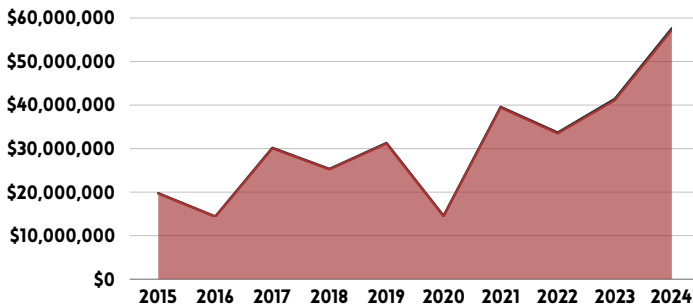

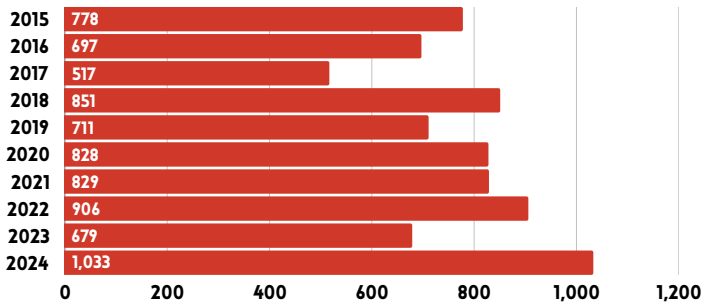

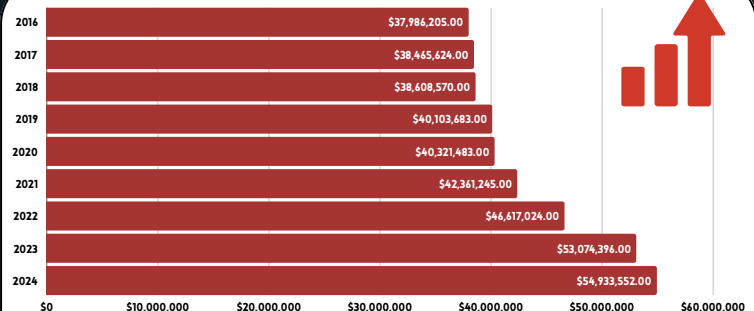

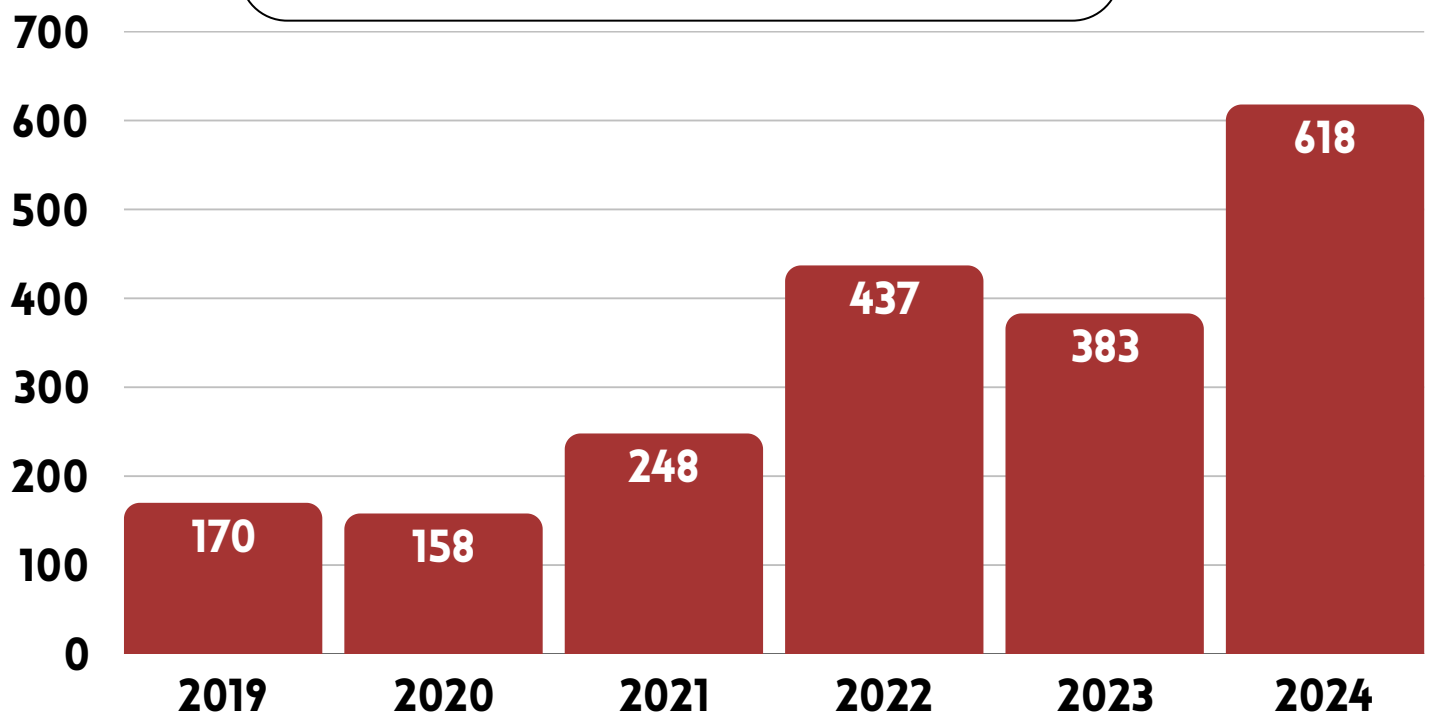

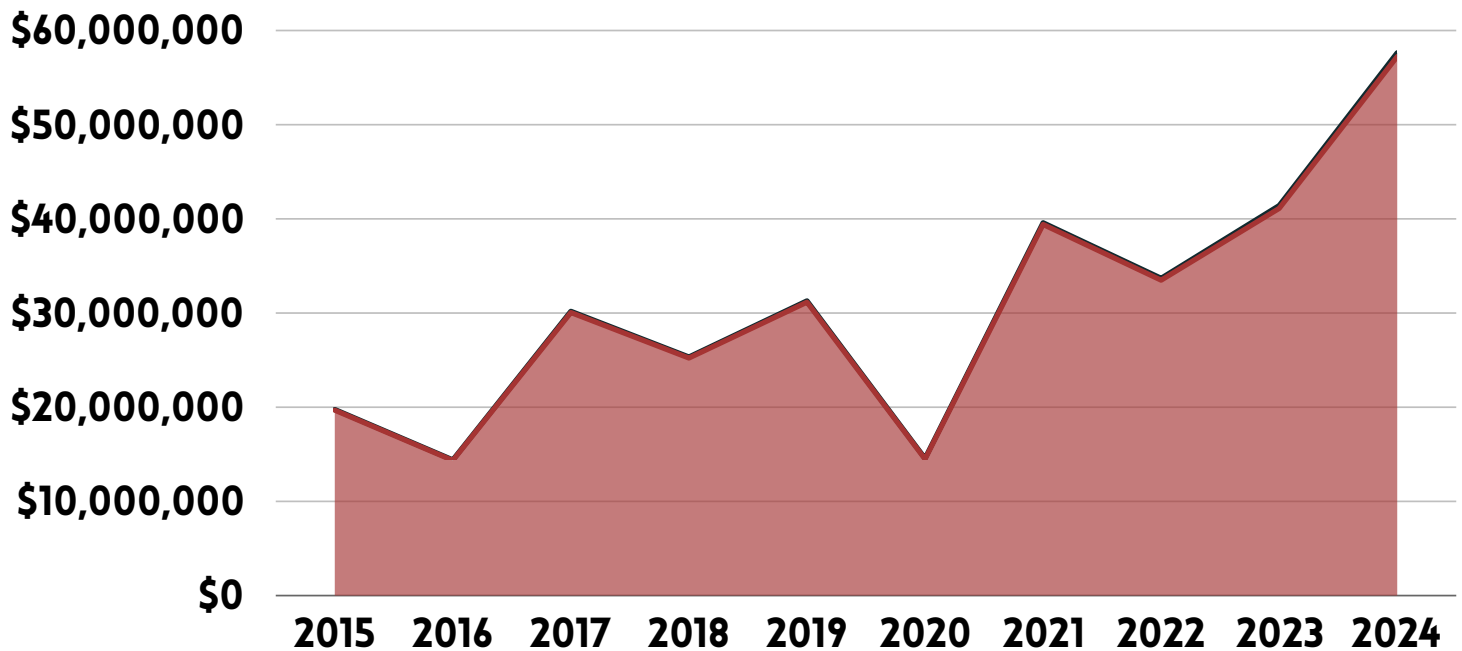

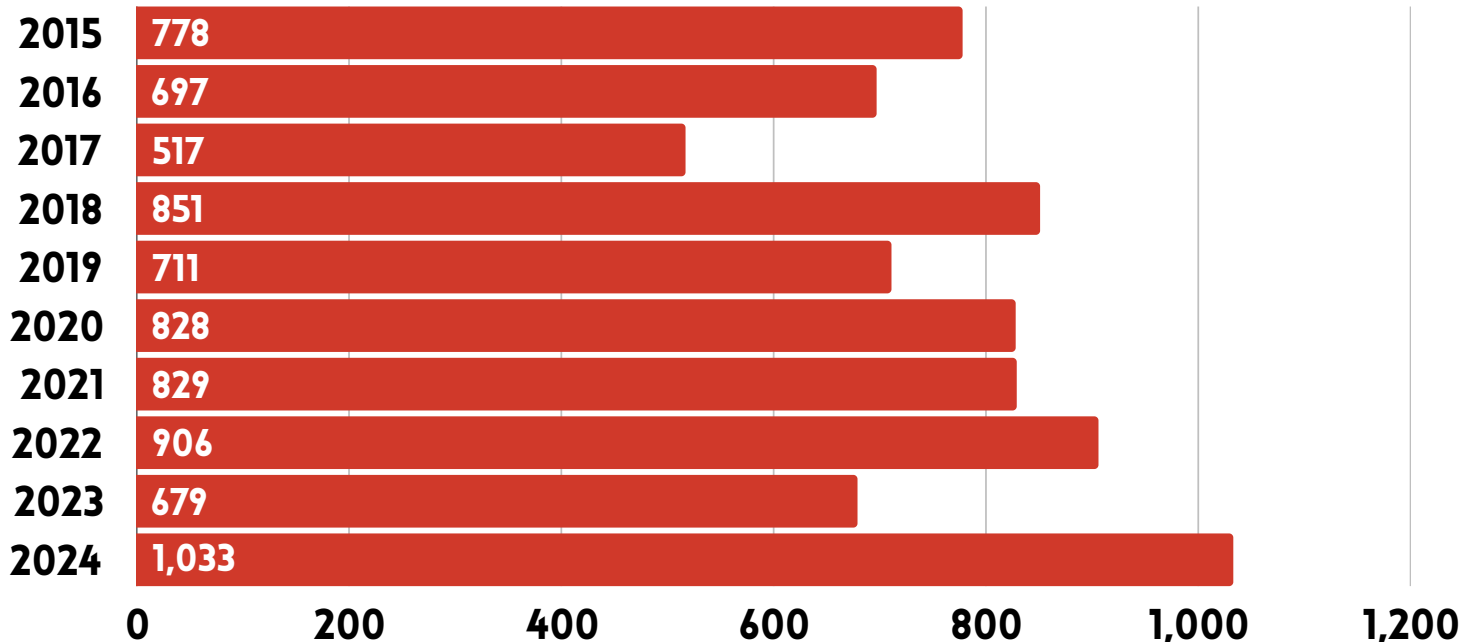

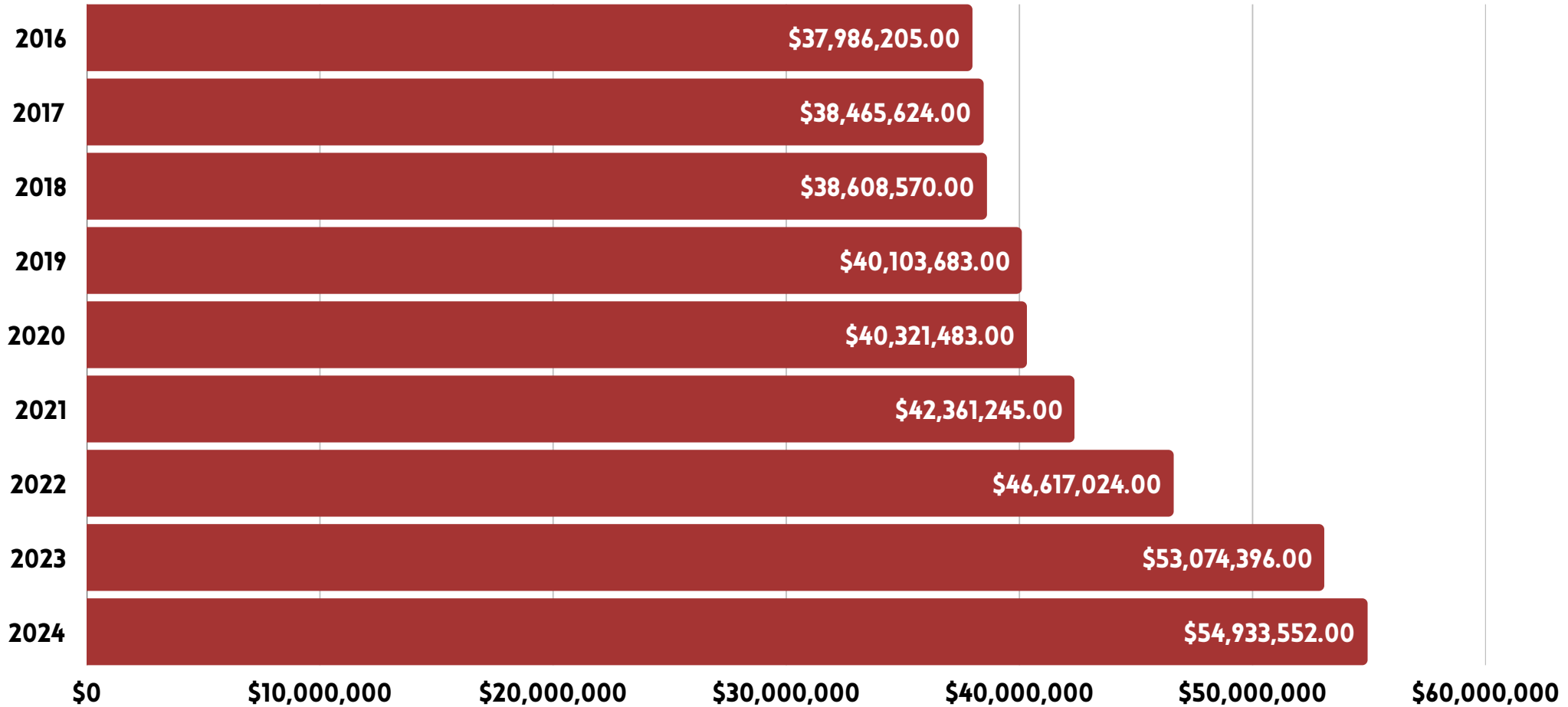
